## **Years of Service Recognition (20/30/40 yrs. of service)**

Sabin will recognize employees with 20 or more yrs. of service with an end of year bonus. Any covered employee will be eligible for a bonus if he or she has 20 + years of service accumulated before the last day of the bonus year. In addition, to be entitled to yrs. of service bonus, an employee must have worked at *least 51% of his/her scheduled hours* in the *year at which the bonus is given*. The bonus will be payable on or about Dec. 1. Please refer to section 3.13 Years of Service Recognition, page 38 of employee handbook.


