2020 Discretionary Profit-Sharing Contribution...

The 2020 Discretionary Profit Sharing is 6%. On September 15th, a 4% Discretionary Profit-Sharing contribution was funded to all eligible employees of the Sabin Metal 401K plan. 2022 PFL Weekly Benefit

The maximum PFL benefit percentage in 2022 has remained unchanged at 67% of the employee's average weekly wage, not to exceed 67% of the statewide average weekly which is \$1,068.36 per week.

The maximum allowable duration of a PFL claim has remained unchanged at 12 weeks. The PFL premium rate for 2022 will remain unchanged at .511%. Maximum employee contribution for 2022 is **\$423.71 per year**. Keep in mind that PFL, like DBL is a required statutory coverage. All premiums are paid through employee contributions.

Vaccination Issue in the Work place

What you need to know.....

The following information was from Harris Beach LLC during the seminar on 9/23/21. These are for informational purposes only so employees are aware of what is going on with the vaccine mandate. HR will continue to monitor the progress and will communicate the final outcome to employees.

Government Vaccination Mandates

- •OSHA Rule for private-sector employers with 100+ employees; *Upcoming-not yet released*.
- ■Executive Order for federal contractors; Covers contractors and subcontractors for the federal government.
- •N.Y. Department of Health rule for healthcare employers; Covering hospitals, nursing homes, long-term care facilities, certain diagnostic and treatment centers
- N.Y. Department of Health rule for public school employees; Covers all public schools, Regular testing or vaccination.

OSHA Rule for Employers With 100+ Employees –Basics

- OSHA "Emergency Temporary Standard" or "ETS"
- •Will obligate employers with 100 or more employees to require vaccination or weekly testing.
- ■\$14,000 for violations
- OSHA has authority to implement an ETS if:
- ■Employees will be exposed to a "grave danger," and
- •A rule is "necessary" to protect the employees from the grave danger.
- Emergency Temporary Standard has a 6-month shelf life unless a "Permanent Standard" replaces it.

Sabin is not mandating vaccination at the moment, pending further decisions by the government & OSHA.

2022 Upstate Minimum Wage Announced.....

On 9/28/21 the Commissioner of Labor announced that the minimum wage for miscellaneous industries in upstate New York will increase to \$13.20/hr. effective 12/31/21. Sabin Metal's starting wage is \$17.00/hr. for general laborers & \$16.00 / hr. for security which both are over 20% more than the NY Upstate Minimum Wage.
